I. Reporting Matters

1. Please review and approve the 2024 Business Report.

(1) Preface

In 2024, global inflation gradually subsided, and interest rate cuts began in the U.S. and Europe. With the recovery of consumer purchasing power, market demand rebounded, leading to faster depletion of inventory by brand customers and normalization of order cycles. Some long-term customers even saw significant order growth after depleting their inventory.

Meanwhile, emerging brands have adopted a direct-to-consumer sales strategy, effectively utilizing e-commerce platforms, social media, and digital advertising. By continuously improving product quality, they have significantly enhanced the consumer experience. In a highly competitive market, they rapidly established a strong brand reputation and customer loyalty, especially among younger generations. Leveraging years of accumulated R&D capabilities, the Company accurately identified the needs of each market segment and swiftly delivered customized products and solutions, capitalizing on the rise of emerging brands and expansion of potential markets.

Despite the uncertainty in global monetary policies and geopolitical tensions, the Company has maintained a prudent and pragmatic business strategy, steadily growing through continuous innovation in R&D. We focused on high-value, niche products while actively expanding our customer base. With close collaboration from long-standing brand partners, the Company recorded the second-highest revenue in its history, delivering substantial value to shareholders.

(2) 2024 Business Plan Implementation Status and Result

A. 2024 Business Plan Implementation Status

(A) Process Optimization: The Company reinforced industrial engineering applications and implemented efficiency and quality-related projects. Ongoing improvement initiatives helped increase workers' productivity. With the assistance of devices and automated hardware/software, the Company shortened learning curves and standardized production and process quality.

(B) Risk Diversification: Following the inventory correction of 2023, the U.S. and European apparel markets gradually recovered in 2024. As market share shifted among brands and retailers, the Company adhered to a diversification strategy to avoid over-reliance on individual clients. It carefully evaluated the financial conditions of potential clients and collaborated with them to establish high-end

brand positioning.

- (C) Compensation and Benefits: In response to the aging population and declining birthrate in Taiwan, the Company continued to enhance salary competitiveness by raising fixed pay and entry-level salaries. Multiple bonus systems were implemented to share business results and incentivize employees. Furthermore, the Company fostered a friendly, diverse, and work-life balanced environment through employee clubs, in-house sports facilities, gyms, and childcare subsidies.

B. 2024 Business Plan Implementation Results and Budget Execution Situation

In 2024, the Company' revenue reached NT\$36.606 billion. Of this, the Fabrics Division accounted for NT\$12.867 billion, representing 35.15% of total revenue, while the Garment Division contributed NT\$23.739 billion, or 64.85% of total revenue. Compared to 2023, this was an increase of NT\$5.92 billion or 19.29%. Operating profit totaled NT\$7.273 billion, an increase of NT\$904 million or 14.19%. Net income after tax amounted to NT\$6.641 billion, an increase of NT\$1.465 billion or 28.30%. Earnings per share (EPS) for 2024 was NT\$24.20.

(3) 2025 Business Plan

A. 2025 Business Plan

(A) Smart Manufacturing Upgrades:

Several products incorporated four key smart manufacturing projects:

(1) intelligent equipment upgrades with smart monitoring devices; (2) process information visualization through data collection and chart presentation for team analysis; (3) AI-integrated smart fabric inspection with Automated Optical Inspection (AOI) to reduce manual inspection and enhance efficiency and accuracy; (4) sensor-driven smart warehouse positioning to improve logistics efficiency. Additionally, production progress and shipping schedules of collaborating factories were integrated with the Company's ERP system to ensure real-time monitoring of operations. Smart devices have replaced repetitive manual and visual tasks, optimizing operations management.

(B) Capacity Expansion:

With the Indonesian garment plant fully operational, the Company will begin the third-phase construction of the Indonesian facility. Leveraging previous experience, construction speed will be accelerated. This move will further strengthen the completeness of the overseas production base, increase order flexibility, respond rapidly to market changes, and effectively mitigate potential tariff risks.

(C) Employer Branding Optimization:

In addition to existing recruitment channels, the Company will increase media exposure to enhance employer branding and attract more outstanding talent. By improving salary competitiveness, raising base pay and new-hire salaries, offering various bonuses, and implementing an employee stock ownership trust plan, the Company shares operating results with employees. The company fosters a friendly, work-life balanced environment, encouraging employees to share their positive experiences, thereby expanding the brand's influence and attracting top talent.

B. 2025 Research and Development Plan

(A) Continued Development of Functional Fabrics

Functional fabric is a core product of the Company. We will continue to incorporate new raw materials and equipment while developing new processes and products to improve quality and yield. In response to the growing demand for eco-friendly and high-end fabrics, we will increase investment in both talent and equipment. The Company will also continue advancing new technologies in weaving and dyeing processes to lead the industry into a new era of innovation and expand the applications of functional textiles.

(B) Collaborative Development with Customers to Create Value:

By working jointly with upstream material suppliers and downstream clients, and leveraging the Company's vertically integrated operations and one-stop sourcing service, we aim to create niche markets and avoid price wars with industry peers. Our R&D staff will collaborate with

clients to develop niche fabrics. Meanwhile, we will cultivate apparel designers to engage in co-design with customers, assisting them in developing apparel brands or expanding market presence. This will gradually increase our ODM ratio and improve product profitability.

(C) Digital Technology and Eco-Friendly Processes:

We will incorporate digital technology into our production processes and pursue innovation in new manufacturing methods. Through the application of big data, IoT, and AI, the Company will integrate industry expertise and collaborate with academia to transform labor-intensive procedures, enhancing production efficiency and product yield per employee. The Company also prioritizes corporate social responsibility, complying with occupational health and safety regulations. Beyond product quality, significant resources are devoted to the development and implementation of environmentally friendly production processes.

Outlook for 2025: Despite the unresolved Russia-Ukraine war and ongoing global tensions, the Israel-Palestine conflict has eased; however, tariff issues are becoming more prominent. The Company will continue its production base diversification strategy and, following the full operation of its Indonesian garment plant, further assess capacity expansion to mitigate tariff risks. At the same time, continued investment in automation hardware and production monitoring software will enhance operational efficiency. In key regions, the Company will focus on local talent development, strengthening managerial training, and promoting localized production. Over the long term, demand for premium apparel remains robust. The Company will expand its market share through product innovation, eco-friendly and automated manufacturing, and continuous R&D innovation. We remain committed to product quality, talent development, and maximizing value for our customers, employees, and shareholders.

The aforementioned Business Report, Financial Statements and Profit Distribution Proposal have been reviewed by the Audit Committee and are considered to be conformed to requirements. Consequently, it is reported for review according to the relevant regulations of Securities and Exchange Act and the Company Act.

3. 2024 Employees' Remuneration Appropriation

Explanation:

- (1) The proposal for the appropriation of 2024 employees' compensation has been approved by the Board of Directors.
- (2) Pursuant to Article 37 of the Articles of Incorporation, if the Company has earnings for the year, it shall allocate no less than 0.1% of the earnings as employees' remuneration. For 2024, the amount appropriated was NT\$9,000,000, which was entirely distributed in cash.
- (3) The remuneration was granted to employees of the Company. The amount distributed was determined by the Chairman under full authorization, based on factors such as seniority, position, performance, overall contribution, special merits, and employee eligibility.

4. Cash Dividend Distribution of 2024 Earnings

Explanation:

- (1) Pursuant to Article 37-1 of the “Articles of Incorporation”, the Board of Directors is authorized to distribute all or part of the dividends and bonuses in the form of cash with a resolution adopted by a majority vote at a meeting of board of directors attended by two-thirds of the total number of directors, and report the resolution to the shareholders' meeting.
- (2) The cash dividend per share is calculated to the integer dollar with the decimal values truncated up. Where the distribution is less than 1 dollar, it would be accounted to Other Income of the Company.
- (3) The Board of Directors passed a resolution on February 27, 2025 to distribute a cash dividend of NT\$17 per share for 2024, with a total amount of NT\$4,664,240,887. The Chairman is authorized to set the ex-dividend date and related matters. If the total number of issued shares changes and affects the dividend distribution rate, the Chairman is authorized to handle the matter with full authority.

5. Sustainability Strategy and Regulations Established in 2024

Explanation:

- (1) Pursuant to Article 5 of “Sustainable Development Best Practice Principles”.
- (2) The Company formulated its sustainability strategy and policies in 2024 as follows:
 - A. In accordance with the reference template for the “Sustainability Committee Charter” issued by the Taiwan Stock Exchange on March 29, 2024, the Company adopted a new “Sustainability Committee Charter” to replace the existing “Regulations for the Establishment and Operations of the Sustainability Committee.”
 - B. In response to the amendments to the “Regulations Governing the Preparation and Filing of Sustainability Reports by TWSE Listed Companies” issued by the Taiwan Stock Exchange on January 26, 2024, as well as international sustainability trends and requirements, the Company revised its “Procedures for Preparation and Verification of the Sustainability Report.”
- (3) All of the above policies and procedures were approved by the Board of Directors.

Proposal: The 2024 Earnings Distribution Plan

Explanation:

- (1) The Company's 2024 Earnings Distribution Proposal includes the beginning retained earnings of NT\$10,086,897,260, net income after tax of NT\$6,640,851,851, and other comprehensive income of NT\$26,187,175. After a 10% legal reserve of NT\$666,703,902 in accordance with the law, the distributable earnings for the year amount to NT\$16,087,232,384. The Board proposes to distribute NT\$4,664,240,887 in cash dividends to shareholders, equivalent to NT\$17 per share. The dividend will be rounded down to the nearest NT dollar.
- (2) Cash dividends shall be calculated based on the number of shares held by shareholders recorded on the distribution record date, and the amount will be rounded down to the nearest whole NT dollar. Any fractional balance below NT\$1 will be recorded as other income of the Company. The Chairman is authorized to determine the record date, distribution date, and all related matters in accordance with laws and regulations.
- (3) Should the total number of issued shares subsequently change and affect the dividend distribution ratio, the Chairman is fully authorized to handle the matter accordingly.
- (4) This proposal has been approved by the Audit Committee and resolved by the Board of Directors. In accordance with Article 37-1 of the Articles of Incorporation, the distribution of cash dividends is to be reported to the Shareholders' Meeting, and the earnings distribution proposal is hereby submitted for approval.

Regarding the profit distribution proposal, it is submitted for approval.

Articles of Incorporation

Chapter I General Principles

Article 1: The Company shall be incorporated under the Company Act. The English name of the Company shall be “Eclat Textile Co., Ltd.”

Article 2: The scope of business of the Company shall be as follows:

1. C301010 Yarn Spinning Mills
2. C302010 Knit Fabric Mills
3. C305010 Printing, Dyeing, and Finishing Mills
4. C306010 Outerwear Knitting Mills
5. C399990 Other Textile Products Manufacturing
6. ZZ99999 All business items that are not prohibited or restricted by law, except those that are subject to special approval.

Article 3: The reinvestment amount of the Company in other enterprises may exceed the limit of forty percent of the paid-in capital specified in the Company Act. The Board of Director is authorized to make resolution on the actual amount.

Article 4: The Company may provide endorsements and guarantees to the external depending upon the business needs. The operation procedure thereof shall be handled according to the Endorsement and Guarantee Policies of the Company.

Article 5: The Company shall have its head office in New Taipei City, and when it is determined to be necessary, branch offices may be established domestically or overseas.

Article 6: (Deleted)

Chapter 2 Shares

Article 7: The total capital of the Company shall be in the amount of NTD 3,000,000,000, divided into 300,000,000 shares, at NTD 10 per share, which may be issued at discrete times, and may be exchanged for shares of large denomination according to the request of shareholders.

Article 8: The shares of the Company shall be registered, which shall be signed or sealed by the Directors on behalf of the Company, and the shares shall be certified with the signatures by the authorized bank for the issuance thereof.

Article 9: For the shares issued by the Company, the printing of share certificates may be exempted; however, they shall be registered with the Centralized Securities Depository Enterprises.

Article 10: Shareholders of the Company performing shareholder services of share transfer, creation of rights and pledges, reporting of loss, inheritance, gift and chop

loss/change or address change etc. and the exercising all of the rights of shareholders, unless the laws and securities regulations specify otherwise, shall be handled according to the “Regulations Governing the Administration of Shareholder Services of Public Companies”.

Article 11: Deleted.

Article 12: Deleted.

Article 13: Deleted.

Article 14: Any change and transfer registration of shares shall be prohibited within 60 days prior to the ordinary shareholders’ meeting, 30 days prior to the extraordinary shareholders’ meeting, or 5 days prior to the record date for the distribution of dividends and bonuses or other interests by the Company.

Chapter 3 Shareholders’ Meeting

Article 15: The shareholders’ meeting is divided into two types of the ordinary shareholder’s meeting and the extraordinary shareholders’ meeting:

1. Ordinary shareholders' meeting shall be convened within six months after the end of each fiscal year.
2. Extraordinary shareholders’ meeting shall be convened when there is an important event and considered necessary by the Board of Directors or shall be convened upon the request of shareholders according to the regulations of the Company Act.

The shareholders’ meeting can be held by means of visual communication network or other methods promulgated by the central competent authority.

In case a shareholders’ meeting is proceeded via visual communication network, the shareholders taking part in such a visual communication meeting shall be deemed to have attended the meeting in person.

Article 16: 30 days prior to the convention of an ordinary shareholders’ meeting and 15 days prior to the convention of an extraordinary shareholder's meeting, a notice indicating the date, location of the meeting and the reason of convention shall be issued to each shareholder in writing or may be informed via electronic method upon the consent of the counterparty; provided that for shareholders with the holding of less than 1,000 shares, announcement method may be adopted.

Article 17: Except where the Company Act and relevant laws specify restrictions or conditions without voting rights, each shareholder shall have one voting right for each share held. Unless otherwise specified in the Company Act, the convention of a shareholders’ meeting shall be attended by a majority of the shareholders representing more than half of the total number of the Company’s outstanding shares, and a resolution of the shareholders’ meeting shall be executed based

on the consents of a majority of the voting rights of attending shareholders.

Article 18: (Deleted)

Article 19: A shareholder may appoint a proxy to attend a shareholders' meeting on his/her/its behalf by executing a power of attorney printed by the Company stating therein the scope of power authorized to the proxy. The regulations for authorizing proxies to attend shareholders' meetings on behalf of the shareholders of the Company shall comply with Article 177 of the Company Act and shall also be handled accordingly to the "Regulations Governing the Use of Proxies for Attendance at Shareholder Meetings of Public Companies" announced by the competent authority.

Article 20: Shareholders' meeting shall be convened by the Board of Directors' meeting, and the Chairman shall be the chairperson of the shareholders' meetings. In case where the Chairman is absent due to reasons, the vice chairman shall act on his behalf. In case there is no vice chairman, or the vice chairman is also on leave or absent or unable to exercise his power and authority for any cause, the Chairman may designate one director to act as a proxy thereof. In case where no designation of proxy is made, the Board of Directors shall elect one director to act as the chairperson. Where a shareholders' meeting is convened by other party with the convening power, such party shall act as the chairperson of the shareholders' meeting. Shareholders' meeting shall be convened according to the Rules of Procedure for Shareholders' Meeting of the Company.

Article 21: Resolutions made in a shareholders' meeting shall be recorded in the meeting minutes and shall be prepared, preserved and issued to all shareholders according to Article 183 of the Company Act.

Chapter 4 Director and Managerial Personnel

Article 22: The Company shall have eleven to thirteen directors. The election of the directors of the Company shall adopt the candidate nomination system prescribed in Article 192-1 of the Company Act, and directors shall be elected by the shareholders' meeting from the candidate roster announced by the Company. Required compliance matters shall be handled according to relevant laws. The total number of registered shares held by all of the directors shall not be less than the percentage specified by the competent authority according to the laws.

In the roster of directors described in the preceding paragraph, the number of independent directors shall not be less than three and shall not be less than one fifth of the total number of Directors. Relevant matters of the professional qualification, shareholding, concurrent job position limitation, nomination and election methods of the Independent Director as well as other necessary requirements shall comply with relevant regulations specified by the competent

authority.

Independent and non-independent directors shall be elected at the same time, but in separately calculated numbers.

Article 23: The term of office of a director is three years, and he/she may be eligible for re-election. Unless otherwise specified in the Company Act, in case where no election of new Directors is affected after expiration of the term of office of existing directors, the term of office of out-going Directors shall be extended until the time new Directors have been elected and assumed their office. The Company establishes the "Audit Committee" according to Article 14-4 of the Securities and Exchange Act. The audit committee shall be composed of the entire number of independent directors.

The number and term of office of audit committee members, powers of the audit committee, and the rules of procedure for meetings of the audit committee shall be handled according to the "Regulations Governing the Exercise of Powers by Audit Committees of Public Companies", and shall be further specified in the audit committee charter.

The Company might establish other functional committees under the Board, the numbers, terms of office, and powers of committee members etc., shall be included in organizational charter to be approved by the board of directors.

Article 24: When the number of vacancies of directors reaches one third or when all of the independent directors are discharged, the Board of Directors shall convene an extraordinary shareholders' meeting within sixty days to fill the vacancies, and the term of office thereof shall be limited to fulfill the unexposed term of office of the predecessor.

Article 25: When the directors are performing duties, regardless of the operating loss or profit of the Company, the Company may pay remuneration for the performance of duties, and the remuneration is authorized to the Board of Directors make determination based on their participation level and value of contribution to the operation of the Company along with the consideration of the standard adopted in the same industry.

Article 26: The Board of Directors organizing the Board of Directors' meeting shall exercise the authorities of the directors according to the laws, and shall be attended by more than two-thirds of the directors along with the consents of the majority of the attending directors in order to elect a Chairman among the directors, may also elect in the same manner a vice chairman of the board

Article 27: Except that the first board of directors' meeting of each session shall be convened according to the Company Act, board of director's meetings shall be convened by the Chairman. Unless otherwise specified in the Company Act, resolutions of Board of Directors' meeting shall be executed based on the attendance of a majority of Directors and the consents of more than half of the

attending Directors.

The notice for the convention of Board of Directors' meeting of the Company may be made in writing, e-mail or facsimile method.

Article 28: Unless otherwise specified in the Company Act, Board of Directors' meetings shall be attended by a majority of the directors. In case where a director cannot attend the meeting due to reasons, he or she may appoint another director to act as a proxy for attending the Board of Directors' meeting on his or her behalf, by presenting a power of attorney indicating the authorization scope of the convention; provided that such appointment shall be limited to one director only. Resolutions of the Board of Directors' meeting shall be executed based on the consent of a majority of the attending directors, and resolution records shall be made and shall be signed and sealed by the chairperson for preservation. Where a Board of Directors' meeting is held as a video conference, the directors attending the meeting through video conference shall be deemed to have attended to the meeting in person.

Article 29: (Deleted)

Article 30: (Deleted)

Article 31: According to the indemnification liabilities required to be borne under the laws within the scope of duties of all of the directors within their term of office, the Company shall purchase liability insurances for the directors in order to reduce and diversify the damage risks of all of the directors, the Company and the shareholders. The Board of Directors is authorized to have the full authority to handle matters related to the application of liability insurances for all of the directors.

Article 32: The Company may have managerial personnel, and the appointment, discharge and remuneration thereof shall be handled according to Article 29 of the Company Act. Within the scope of authorization, the managerial personnel are empowered to manage affairs and signature for the Company, and the Board of Directors shall establish relevant scope of authorization and authorization regulations.

Article 33: The President of the Company shall handle daily affairs of the Company according to the resolutions of the Board of Directors' meeting.

Article 34: Deleted.

Chapter 5 Accounting

Article 35: The accounting fiscal year of the Company shall start from January 1 to December 31, and settlement shall be performed at the end of each fiscal year.

Article 36: The Board of Directors shall prepare the business report, financial statement and proposal on distribution of surplus earnings or loss of-setting according to the Company Act at the end of each fiscal year, and shall submit to the Audit

Committee for auditing thirty days prior to the convention of ordinary shareholders' meeting, in order to issue a report for submission to the shareholders' meeting for approval.

Article 37: Where the Company has a profit (the term "profit" refers to the income before deducting the distribution of employee compensation from the income before tax) in current year, if there is surplus after covering the accumulated loss, no less than 0.1% shall be appropriated for the employee's compensation for the distribution according to the resolution of the Board of Directors' meeting, and be reported to the shareholders' meeting. The distribution of employee's compensation may be made in the form of shares or cash

Article 37-1: Where the Company has a profit in current year, when allocating its surplus profits after having paid all taxes and dues, shall first set aside ten percent of said profits as legal reserve. Where such legal reserve amounts to the total paid-in capital, this provision may be exempted. Aside from the aforesaid legal reserve, the company may, under its Articles of Incorporation or by resolution of the meeting of shareholders, set aside another sum as special reserve, along with the undistributed earnings at the beginning. When the board of directors establishes the earnings distribution proposal and the method of distribution in cash is to be adopted, according to Paragraph 5 of Article 240 of the Company Act, the board of directors is authorized to distribute the distributable dividends and bonuses in whole or in part in cash after a resolution has been adopted by a majority vote at a meeting of the board of directors attended by two-thirds of the total number of directors; and in addition, a report of such distribution shall be submitted to the shareholders' meeting; when it is to be distributed in the form of new shares, it shall be submitted to the shareholders' meeting for resolution before the distribution.

According to the provision of Article 241 of the Company Act, the legal reserve and the capital reserve, in whole or in part, are distributed in the form of new shares or cash; when the form of cash is adopted, distribution shall be made based on the resolution of a board of directors' meeting attended by more than two-thirds of directors with a majority of voting rights of the attending directors, which shall also be reported to the shareholders' meeting; when the distribution is made by issuing new shares, it shall be submitted to the shareholders' meeting for resolution before distribution.

The present industrial development of the Company is at the growing stage, and there are plans for expansion of production lines and fund demands.

Consequently, during the distribution of surplus earnings, the Board of Directors shall consider the investment plan, financial structure, future fund demand and profit status of the Company, and under the consideration that there are no other special conditions, it shall not be lower than 50% of the net income of the

current year after the deduction of the compensation loss according to the paragraph I under this Article, for the Board of Directors to submit proposal to the shareholders' meeting for resolution before the execution thereof. However, the total amount of dividends shall not be less than 20% of amount of cash dividends distributed.

Article 38: (Delete)

Chapter 6 Supplementary Provisions

Article 39: For any matters not specified in this Article of Incorporation, such matters shall be handled according to the regulations of the Company Act.

Article 40: These Articles of Incorporation shall become effective after the resolution of the shareholders' meeting, and the same requirement shall be applied to the amendment thereof.

Article 41: These Articles of Incorporation were established on November 10, 1977.

Rules Governing the Procedures for Shareholders' Meetings

1. To establish excellent board of directors meeting governance system, sound supervisory function and enhance the management performance of the Company, the Company establishes these rules according to the Article 5 of the Corporate Governance Best Practice Principles for TWSE/TPEX Listed Companies as the basis for compliance.
2. The rules of procedures for the Company's shareholders meetings, except as otherwise provided by law, regulation, or the articles of incorporation, shall be as provided in these Rules.

The Company shall specify the shareholder, solicitor, and proxy agent. (collectively, "shareholders") in meeting notices the time during which shareholder attendance registrations will be accepted, the place to register for attendance, and other matters for attention.

The time during which shareholder attendance registrations will be accepted, as stated in the preceding paragraph, shall be at least 30 minutes prior to the time the meeting commences. The place at which attendance registrations are accepted shall be clearly marked and a sufficient number of suitable personnel assigned to handle the registrations. For virtual shareholders' meetings, shareholders may begin to register on the virtual meeting platform 30 minutes before the meeting starts. Shareholders completing registration will be deemed as attending the shareholders' meeting in person.

3. Unless otherwise provided by law or regulation, the Company's shareholders meetings shall be convened by the board of directors.

Unless otherwise provided in "Regulations Governing the Administration of Shareholder Services of Public Companies", a company that will convene a shareholders' meeting with video conferencing shall expressly provide for such meetings in its Articles of Incorporation and obtain a resolution of its board of directors. Furthermore, convening of a virtual-only shareholders' meeting shall require a resolution adopted by a majority vote at a meeting of the board of directors attended by at least two-thirds of the total number of directors.

Changes to how the Company convenes its shareholders' meeting shall be resolved by the board of directors, and shall be made no later than the mailing of the shareholders' meeting notice.

For the convention of an ordinary shareholders' meeting, meeting agenda book shall be prepared and notices shall be sent to all shareholders thirty days before the convention of the meeting, and for shareholders holding less than 1,000 registered shares, the announcement method of uploading onto the Market Observation Post

System (MOPS) may be adopted 30 days before the convention of the meeting. For the convention of an extraordinary shareholders' meeting, notices shall be sent to all shareholders 15 days before the convention of the meeting, and for shareholders holding less than 1,000 registered shares, the announcement method of uploading onto the MOPS may be adopted 15 days before the convention of the meeting. If, however, this Corporation has the paid-in capital of NT\$10 billion or more as of the last day of the most current fiscal year, or total shareholding of foreign shareholders and PRC shareholders reaches 30% or more as recorded in the register of shareholders of the shareholders meeting held in the immediately preceding year, transmission of these electronic files shall be made by 30 days before the regular shareholders meeting.

The Company shall make the meeting agenda and supplemental meeting materials in the preceding paragraph available to shareholders for review in the following manner on the date of the shareholders' meeting:

- I. For physical shareholders' meetings, to be distributed on-site at the meeting.
- II. For hybrid shareholders' meetings, to be distributed on-site at the meeting and shared on the virtual meeting platform.
- III. For virtual-only shareholders' meetings, electronic files shall be shared on the virtual meeting platform.

The notice and announcement shall describe the reason of convention. Where the consent of the counterparty of the notice is obtained, an electronic method may be adopted.

Election or dismissal of directors, amendments to the articles of incorporation, reduction of capital, application for the approval of ceasing its status as a public company, approval of competing with the Company by directors, surplus profit distributed in the form of new shares, reserve distributed in the form of new shares, the dissolution, merger, or demerger of the corporation, or any matter under Article 185, paragraph 1 of the Company Act, and the matters described as the Article 26-1 and 43-6 of the Securities and Exchange Act, the Article 56-1 and 60-2 of the Regulations Governing the Offering and Issuance of Securities by Securities Issuers shall be set out in the notice of the reasons for convening the shareholders meeting. None of the above matters may be raised by an extraordinary motion.

The reason of convention of shareholders' meeting has indicated the re-election of directors, and the date of assuming the position is also indicated. After the re-election is completed in such session of shareholder's meeting, the date of assuming the position shall not be changed through extempore motion or other methods.

A shareholder holding 1 percent or more of the total number of issued shares may submit to the Company a proposal for discussion at a regular shareholders

meeting. Such proposals, however, are limited to one item only, and no proposal containing more than one item will be included in the meeting agenda. In addition, when the circumstances of any subparagraph of Article 172-1, paragraph 4 of the Company Act apply to a proposal put forward by a shareholder, the board of directors may exclude it from the agenda. Nevertheless, shareholders may raise an advisory proposal for the purpose of promoting the Company to improve the public interest or to fulfill the corporate social responsibility, where should follow comply with the Article 172-1, of the “Company Act”. Such proposals are limited to one matter, and in case a proposal contains more than one matter, such proposal shall not be included in the agenda.

Prior to the book closure date before a regular shareholders meeting is held, the Company shall publicly announce that it will receive shareholder proposals by written or electronic, and the location and time period for their submission; the period for submission of shareholder proposals may not be less than 10 days..

Shareholder-submitted proposals are limited to 300 words, and no proposal containing more than 300 words will be included in the meeting agenda book. The shareholder making the proposal shall be present in person or by proxy at the regular shareholders meeting and take part in discussion of the proposal.

Prior to the date for issuance of notice of a shareholders meeting, the Company shall inform the shareholders who submitted proposals of the proposal screening results, and shall list in the meeting notice the proposals that conform to the provisions of this article. At the shareholders meeting the board of directors shall explain the reasons for exclusion of any shareholder proposals not included in the agenda.

4. The attending shareholders may hand in a sign-in card in lieu of signing in.

The Company shall furnish attending shareholders with the meeting agenda book, annual report, attendance card, speaker’s slips, voting slips, and other meeting materials. Where there is an election of directors or supervisors, pre-printed ballots shall also be furnished. Shareholders shall attend shareholders meetings based on attendance cards, sign-in cards, or other certificates of attendance. Solicitors soliciting proxy forms shall also bring identification documents for verification.

When the government or a juristic person is a shareholder, it may be represented by more than one representative at a shareholders meeting.

When a juristic person is appointed to attend as proxy, it may designate only one person to represent it in the meeting.

In the event of a virtual shareholders’ meeting, shareholders wishing to attend the meeting online shall register with the Company two days before the meeting date.

In the event of a virtual shareholders’ meeting, the Company shall upload the

meeting agenda book, annual report and other meeting materials to the virtual meeting platform at least 30 minutes before the meeting starts, and keep this information disclosed until the end of the meeting.

4-1 To convene a virtual shareholders' meeting, the Company shall include the following particulars in the shareholders' meeting notice:

I. How shareholders attend the virtual meeting and exercise their rights.

II. Actions to be taken if the virtual meeting platform or participation in the virtual meeting is obstructed due to natural disasters, accidents or other force majeure events, at least covering the following particulars:

(I) To what time the meeting is postponed or from what time the meeting will resume if the above obstruction continues and cannot be removed, and the date to which the meeting is postponed or on which the meeting will resume.

(II) Shareholders not having registered to attend the affected virtual shareholders' meeting shall not attend the postponed or resumed session.

(III) In case of a hybrid shareholders' meeting, when the virtual meeting cannot be continued, if the total number of shares represented at the meeting, after deducting those represented by shareholders attending the virtual shareholders' meeting online, meets the minimum legal requirement for a shareholders' meeting, then the meeting shall continue. The shares represented by shareholders attending the virtual meeting online shall be counted towards the total number of shares represented by shareholders present at the meeting, and the shareholders attending the virtual meeting online shall be deemed abstaining from voting on all proposals on the meeting agenda of that shareholders' meeting.

(IV) Actions to be taken if the outcome of all proposals has been announced and an extraordinary motion has not been carried out.

III. To convene a virtual-only shareholders' meeting, appropriate alternative measures available to shareholders with difficulties in attending a virtual shareholders' meeting online shall be specified. Except in the circumstances set out in "Regulations Governing the Administration of Shareholder Services of Public Companies" Article 44-9, paragraph 6, it shall at least provide the shareholders with connection facilities and necessary assistance, and specify the period during which shareholders may apply to the company and other related matters requiring attention.

5. Attendance at shareholders meetings shall be calculated based on numbers of shares. The number of shares in attendance shall be calculated according to the shares indicated by the attendance book, sign-in cards and the shares checked in on the virtual meeting platform plus the number of shares whose voting rights are exercised by correspondence or electronically.

Voting at a shareholders meeting shall be calculated based the number of shares. With respect to resolutions of shareholders meetings, the number of shares held by a shareholder with no voting rights shall not be calculated as part of the total number of issued shares.

When a shareholder is an interested party in relation to an agenda item, and there is the likelihood that such a relationship would prejudice the interests of the Company, that shareholder may not vote on that item, and may not exercise voting rights as proxy for any other shareholder. The number of shares for which voting rights may not be exercised shall not be calculated as part of the voting rights represented by attending shareholders.

With the exception of a trust enterprise or a shareholder services agent approved by the competent securities authority, when one person is concurrently appointed as proxy by two or more shareholders, the voting rights represented by that proxy may not exceed 3 percent of the voting rights represented by the total number of issued shares. If that percentage is exceeded, the voting rights in excess of that percentage shall not be included in the calculation.

6. The venue for a shareholders meeting shall be the premises of the Company, or a place easily accessible to shareholders and suitable for a shareholders meeting. The meeting may begin no earlier than 9 a.m. and no later than 3 p.m. Full consideration shall be given to the opinions of the independent directors with respect to the place and time of the meeting.

The restrictions on the place of the meeting shall not apply when the Company convenes a virtual-only shareholders' meeting.

7. If a shareholders meeting is convened by the board of directors, the meeting shall be chaired by the chairman of the board. When the chairman of the board is on leave or for any reason unable to exercise the powers of the chairman, the vice chairman shall act in place of the chairman. If there is no vice chairman or the vice chairman also is on leave or for any reason unable to exercise the powers of the vice chairman, the chairman shall appoint one of the managing directors to act as chairman, or, if there are no managing directors, one of the directors shall be appointed to act as the chairman. Where the chairman does not make such a designation, the managing directors or the directors shall select from among themselves one person to serve as the chairman.

It is advisable that shareholders meetings convened by the board of directors be chaired by the chairperson of the board in person and attended by a majority of the directors, at least one independent director in person, and at least one member of each functional committee on behalf of the committee. The attendance shall be recorded in the meeting minutes.

If a shareholders meeting is convened by a party with power to convene but

other than the board of directors, the convening party shall chair the meeting. When there are two or more such convening parties, they shall mutually select a chair from among themselves.

8. Attorneys, certified public accountants, or related persons appointed by the Company may attend a shareholders meeting.

Personnel who handling administrative affairs of a shareholders' meeting shall wear identification cards or arm bands.

9. The Company shall make video record of the registration procedure and make an uninterrupted audio and video recording of the proceedings of the shareholders meeting, and the voting and vote counting procedures.

The recorded materials of the preceding paragraph shall be retained for at least 1 year. If, however, a shareholder files a lawsuit pursuant to Article 189 of the Company Act, the recording shall be retained until the conclusion of the litigation.

Where a shareholders' meeting is held online, the Company shall keep records of shareholder registration, sign-in, check-in, questions raised, votes cast and results of votes counted by the Company, and continuously audio and video record, without interruption, the proceedings of the virtual meeting from beginning to end.

The information and audio and video recording in the preceding paragraph shall be properly kept by the Company during the entirety of its existence, and copies of the audio and video recording shall be provided to and kept by the party appointed to handle matters of the virtual meeting.

10. The chair shall call the meeting to order at the appointed meeting time, meanwhile announcing the relevant information regarding non-voting shares and the number of shares in attendance.

However, when the attending shareholders do not represent a majority of the total number of issued shares, the chair may announce a postponement, provided that no more than two such postponements, for a combined total of no more than 1 hour, may be made. If the quorum is not met after two postponements and the attending shareholders still represent less than one third of the total number of issued shares, the chair shall declare the meeting adjourned. In the event of a virtual shareholders' meeting, the Company shall also declare the meeting adjourned on the virtual meeting platform.

If the quorum is not met after two postponements as referred to in the preceding paragraph, but the attending shareholders represent one third or more of the total number of issued shares, a tentative resolution may be adopted pursuant to Article 175, paragraph 1 of the Company Act; all shareholders shall be notified of the tentative resolution and another shareholders meeting shall be convened within 1 month. In the event of a virtual shareholders' meeting, shareholders intending to attend the meeting online shall re-register to the Company in accordance with

Article 4.

When, prior to conclusion of the meeting, the attending shareholders represent a majority of the total number of issued shares, the chair may resubmit the tentative resolution for a vote by the shareholders meeting pursuant to Article 174 of the Company Act.

11. If a shareholders meeting is convened by the board of directors, the meeting agenda shall be set by the board of directors. All the discussion matters should be voted. The meeting shall proceed in the order set by the agenda, which may not be changed without a resolution of the shareholders meeting.

The provisions of the preceding paragraph apply *mutatis mutandis* to a shareholders meeting convened by a party with the power to convene that is not the board of directors.

The chair may not declare the meeting adjourned prior to completion of deliberation on the meeting agenda of the preceding two paragraphs, except by a resolution of the shareholders meeting.

If the chair declares the meeting adjourned in violation of the rules of procedure, the other members of the board of directors shall promptly assist the attending shareholders in electing a new chair in accordance with statutory procedures, by agreement of a majority of the votes represented by the attending shareholders, and then continue the meeting.

12. Before speaking, an attending shareholder must specify on a speaker's slip the subject of the speech, his/her shareholder account number (or attendance card number), and account name. The order in which shareholders speak will be set by the chair.

A shareholder in attendance who has submitted a speaker's slip but does not actually speak shall be deemed to have not spoken. When the content of the speech does not correspond to the subject given on the speaker's slip, the spoken content shall prevail.

When an attending shareholder is speaking, other shareholders may not speak or interrupt unless they have sought and obtained the consent of the chair and the shareholder that has the floor; the chair shall stop any violation.

13. Except with the consent of the chair, a shareholder may not speak more than twice on the same proposal, and a single speech may not exceed 5 minutes.

If the shareholder's speech violates the above provisions or exceeds the scope of the agenda item, the chair may prevent the shareholder from doing so.

When a juristic person shareholder appoints two or more representatives to attend a shareholders meeting, only one of the representatives so appointed may speak on the same proposal.

Where a virtual shareholders' meeting is convened, shareholders attending the

virtual meeting online may raise questions in writing at the virtual meeting platform from the chair declaring the meeting open until the chair declares the meeting adjourned. No more than two questions for the same proposal may be raised. Each question shall contain no more than 200 words. The regulations specified in Article 12 and Paragraph 1 to Paragraph 3 of Article 13 do not apply.

As long as questions so raised in accordance with the preceding paragraph are not in violation of the regulations or beyond the scope of a proposal, it is advisable the questions be disclosed to the public at the virtual meeting platform.

14. After an attending shareholder has spoken, the chair may respond in person or direct relevant personnel to respond.
15. The chair shall allow ample opportunity during the meeting for explanation and discussion of proposals and of amendments or extraordinary motions put forward by the shareholders; when the chair is of the opinion that a proposal has been discussed sufficiently to put it to a vote, the chair may announce the discussion closed and call for a vote, arrange adequate time for vote as well.
16. The election of directors at a shareholders meeting shall be held in accordance with the applicable election and appointment rules adopted by the Company, and the voting results shall be announced on-site immediately, including the names of those elected as directors, the numbers of votes with which they were elected, and the list of directors candidate who are not elected and the number of election rights obtained.

The ballots for the election referred to in the preceding paragraph shall be sealed with the signatures of the monitoring personnel and kept in proper custody for at least 1 year. However, where a shareholder files a lawsuit pursuant to Article 189 of the Company Act, the files shall be retained until the conclusion of the litigation.

17. Vote monitoring and counting personnel for the voting on a proposal shall be appointed by the chair, provided that all monitoring personnel shall be shareholders of the Company. Vote counting for shareholders meeting proposals or elections shall be conducted in public at the place of the shareholders meeting. Immediately after vote counting has been completed, the results of the voting, including the statistical tallies of the numbers of votes, shall be announced on-site at the meeting, and a record made of the vote.
18. When a meeting is in progress, the chair may announce a break based on time considerations. If a force majeure event occurs, the chair may rule the meeting temporarily suspended and announce a time when, in view of the circumstances, the meeting will be resumed.

If the meeting venue is no longer available for continued use and not all of the items on the meeting agenda book have been addressed, the shareholders meeting may adopt a resolution to resume the meeting at another venue.

A resolution may be adopted at a shareholders meeting to defer or resume the meeting within 5 days in accordance with Article 182 of the Company Act.

19. A shareholder shall be entitled to one vote for each share held, except when the shares are restricted shares or are deemed non-voting shares under Article 179, paragraph 2 of the Company Act.

When the Company holds a shareholders meeting, it should allow the shareholders to exercise voting rights by electronic and correspondence means. When voting rights are exercised by correspondence or electronic means, the method of exercise shall be specified in the shareholders meeting notice. A shareholder exercising voting rights by correspondence or electronic means will be deemed to have attended the meeting in person, but to have waived his/her rights with respect to the extraordinary motions and amendments to original proposals of that meeting; it is therefore advisable that the Company avoid the submission of extraordinary motions and amendments to original proposals.

A shareholder intending to exercise voting rights by correspondence or electronic means under the preceding paragraph shall deliver a written declaration of intent to the Company before 2 days before the date of the shareholders meeting. When duplicate declarations of intent are delivered, the one received earliest shall prevail, except when a declaration is made to cancel the earlier declaration of intent.

After a shareholder has exercised voting rights by correspondence or electronic means, in the event the shareholder intends to attend the shareholders meeting in person or online, a written declaration of intent to retract the voting rights already exercised under the preceding paragraph shall be made known to the Company, by the same means by which the voting rights were exercised, before 2 business days before the date of the shareholders meeting. If the notice of retraction is submitted after that time, the voting rights already exercised by correspondence or electronic means shall prevail. When a shareholder has exercised voting rights both by correspondence or electronic means and by appointing a proxy to attend a shareholders meeting, the voting rights exercised by the proxy in the meeting shall prevail.

After a proxy form is delivered to the Company, a shareholder wishes attend the shareholders meeting online, a written notice of proxy cancellation shall be submitted to the Company two business days before the meeting date. If the cancellation notice is submitted after that time, votes cast at the meeting by the proxy shall prevail.

Except as otherwise provided in the Company Act and in the Company's articles of incorporation, the passage of a proposal shall require an affirmative vote of a majority of the voting rights represented by the attending shareholders. At the time of a vote, for each proposal, the chair or a person designated by the chair shall first

announce the total number of voting rights represented by the attending shareholders, followed by a poll of the shareholders. After the conclusion of the meeting, on the same day it is held, the results for each proposal, based on the numbers of votes for and against and the number of abstentions, shall be entered into the MOPS.

When the Company convenes a virtual shareholders' meeting, after the chair declares the meeting open, shareholders attending the meeting online shall cast votes on proposals and elections on the virtual meeting platform before the chair announces the voting session ends or will be deemed abstained from voting.

In the event of a virtual shareholders' meeting, votes shall be counted at once after the chair announces the voting session ends, and the results of votes and elections shall be announced immediately.

When the Company convenes a hybrid shareholders' meeting, if shareholders who have registered to attend the meeting online in accordance with Article 4 decide to attend the physical shareholders' meeting in person, they shall revoke their registration two days before the shareholders' meeting in the same manner as they registered. If their registration is not revoked within the time limit, they may only attend the shareholders' meeting online.

When shareholders exercise voting rights by correspondence or electronic means, unless they have withdrawn the declaration of intent and attended the shareholders' meeting online, except for extraordinary motions, they will not exercise voting rights on the original proposals or make any amendments to the original proposals or exercise voting rights on amendments to the original proposal.

20. When there is an amendment or alternative to a proposal, the chair shall present the amended or alternative proposal together with the original proposal and decide the order in which they will be put to a vote. When any one among them is passed, the other proposals will then be deemed rejected, and no further voting shall be required.
21. On the day of a shareholders' meeting, the Company shall compile in the prescribed format a statistical statement of the number of shares obtained by solicitors through solicitation, the number of shares represented by proxies and the number of shares represented by shareholders attending the meeting by correspondence or electronic means, and shall make an express disclosure of the same at the place of the shareholders' meeting. In the event of a virtual shareholders' meeting, the Company shall upload the above meeting materials to the virtual meeting platform at least 30 minutes before the meeting starts, and keep this information disclosed until the end of the meeting.

During the Company's virtual shareholders' meeting, when the meeting is called to order, the total number of shares represented at the meeting shall be disclosed

on the virtual meeting platform. The same shall apply whenever the total number of shares represented at the meeting and a new tally of votes are released during the meeting.

22. The chair may direct the proctors or security personnel to help maintain order at the meeting place. When proctors or security personnel help maintain order at the meeting place, they shall wear an identification card or armband bearing the word "Proctor."

At the place of a shareholders meeting, if a shareholder attempts to speak through any device other than the public address equipment set up by the Company, the chair may prevent the shareholder from so doing.

When a shareholder violates the rules of procedure and defies the chair's correction, obstructing the proceedings and refusing to heed calls to stop, the chair may direct the proctors or security personnel to escort the shareholder from the meeting.

23. Matters relating to the resolutions of a shareholders meeting shall be recorded in the meeting minutes. The meeting minutes shall be signed or sealed by the chair of the meeting and a copy distributed to each shareholder within 20 days after the conclusion of the meeting. The meeting minutes may be produced and distributed in electronic form.

The Company may distribute the meeting minutes of the preceding paragraph by means of a public announcement made through the MOPS.

The meeting minutes shall accurately record the year, month, day, and place of the meeting, the chair's full name, the methods by which resolutions were adopted, and a summary of the deliberations and their voting results (including the numbers of votes). The Company shall disclose the voting numbers of each candidate, which shall be retained for the duration of the existence of the Company.

Where a virtual shareholders' meeting is convened, in addition to the particulars to be included in the meeting minutes as described in the preceding paragraph, the start time and end time of the shareholders' meeting, how the meeting is convened, the chair's and secretary's name, and actions to be taken in the event of a disruption to the virtual meeting platform or participation in the meeting online due to natural disasters, accidents or other force majeure events, and how issues are dealt with shall also be included in the minutes.

When convening a virtual-only shareholders' meeting, other than compliance with the requirements in the preceding paragraph, the Company shall specify in the meeting minutes alternative measures available to shareholders with difficulties in attending a virtual-only shareholders' meeting online.

24. In the event of a virtual shareholders' meeting, the Company shall disclose real-time results of votes and election immediately after the end of the voting

session on the virtual meeting platform according to the regulations, and this disclosure shall continue at least 15 minutes after the chair has announced the meeting adjourned.

25. When the Company convenes a virtual-only shareholders' meeting, both the chair and secretary shall be in the same location, and the chair shall declare the address of their location when the meeting is called to order.
26. In the event of a virtual shareholders' meeting, when declaring the meeting open, the chair shall also declare, unless, under a circumstance where a meeting is not required to be postponed to or resumed at another time under Paragraph 4 of Article 44-20 of the Regulations Governing the Administration of Shareholder Services of Public Companies, if the virtual meeting platform or participation in the virtual meeting is obstructed due to natural disasters, accidents or other force majeure events before the chair has announced the meeting adjourned, and the obstruction continues for more than 30 minutes, the meeting shall be postponed to or resumed on another date within five days, in which case Article 182 of the Company Act shall not apply.

For a meeting to be postponed or resumed, as described in the preceding paragraph, shareholders who have not registered to participate in the affected shareholders' meeting online shall not attend the postponed or resumed session.

For a meeting to be postponed or resumed under Paragraph 1, the number of shares represented by, and voting rights and election rights exercised by the shareholders who have registered to participate in the affected shareholders' meeting and have successfully signed in the meeting, but do not attend the postpone or resumed session, at the affected shareholders' meeting, shall be counted towards the total number of shares, number of voting rights and number of election rights represented at the postponed or resumed session.

During a postponed or resumed session of a shareholders' meeting held under Paragraph 1, no further discussion or resolution is required for proposals for which votes have been cast and counted and results or a list of elected directors and supervisors have been announced.

When the Company convenes a hybrid shareholders' meeting, and the virtual meeting cannot continue as described in Paragraph 1, if the total number of shares represented at the meeting, after deducting those represented by shareholders attending the virtual shareholders' meeting online, still meets the minimum legal requirement for a shareholders' meeting, then the shareholders' meeting shall continue, and not postponement or resumption thereof under Paragraph 1 is required.

Under the circumstances where a meeting should continue as in the preceding Paragraph, the shares represented by shareholders attending the virtual meeting

online shall be counted towards the total number of shares represented by shareholders present at the meeting, provided these shareholders shall be deemed abstaining from voting on all proposals on meeting agenda of that shareholders' meeting.

When postponing or resuming a meeting according to Paragraph 1, the Company shall handle the preparatory work based on the date of the original shareholders' meeting in accordance with the requirements listed under Paragraph 7 of Article 44-20 of the Regulations Governing the Administration of Shareholder Services of Public Companies.

For dates or period set forth under the second half of Article 12 and Paragraph 3 of Article 13 of Regulations Governing the Use of Proxies for Attendance at Shareholder Meetings of Public Companies, and Paragraph 2 of Article 44-5, Article 44-15, and Paragraph 1 of Article 44-17 of the Regulations Governing the Administration of Shareholder Services of Public Companies, the Company shall handle the matter based on the date of the shareholders' meeting that is postponed or resumed under Paragraph 1.

27. When convening a virtual-only shareholders' meeting, the Company shall provide appropriate alternative measures available to shareholders with difficulties in attending a virtual shareholders' meeting online. Except in the circumstances set out in "Regulations Governing the Administration of Shareholder Services of Public Companies" Article 44-9, paragraph 6, it shall at least provide the shareholders with connection facilities and necessary assistance, and specify the period during which shareholders may apply to the company and other related matters requiring attention.
28. These Rules, and any amendments hereto, shall be implemented after adoption by shareholders meetings.

Opinion

We have audited the accompanying financial statements of Eclat Textile Co., Ltd. ("the Company"), which comprise the balance sheets as of December 31, 2024 and 2023, and the statements of comprehensive income, changes in equity and cash flows for the years then ended, and notes to the financial statements, including a summary of significant accounting policies.

In our opinion, the accompanying financial statements present fairly, in all material respects, the financial position of the Company as of December 31, 2024 and 2023, and its financial performance and its cash flows for the years ended December 31, 2024 and 2023 in accordance with the Regulations Governing the Preparation of Financial Reports by Securities Issuers.

Revenue recognition and cut-off

Please refer to note 4(p) for details of the accounting policies of the recognition of revenue and note 6(p) revenue from contracts with customers.

How the matter was addressed in our audit

Revenue recognition of the Company is the main concern of the financial report users. Therefore, the assessment of revenue recognition is the key audit matter in our audit.

Our principal audit procedures included:

Testing the design and implementation of internal control over revenue recognition, inspecting the accuracy of revenue recognition, reconciling between sales systems and general ledger, implementing cut off test of revenues and further inspecting related transaction documents to ensure that the revenue is recorded in the appropriate period.

Responsibilities of Management and Those Charged with Governance for the Financial Statements

Management is responsible for the preparation and fair presentation of the financial statements in accordance with the Regulations Governing the Preparation of Financial Reports by Securities Issuers and for such internal control as management determines is necessary to enable the preparation of financial statements that are free from material misstatement due to fraud or error.

In preparing the financial statements, management is responsible for assessing the Company's ability to continue as a going concern, disclosing, as applicable, matters related to going concern and using the going concern basis of accounting unless management either intends to liquidate the Company or to cease operations, or has no realistic alternative but to do so.

Those charged with governance (including members of the Audit Committee) are responsible for overseeing the Company's financial reporting process.

Auditor's Responsibilities for the Audit of the Financial Statements

Our objectives are to obtain reasonable assurance about whether the financial statements as a whole are free from material misstatement due to fraud or error, and to issue an auditor's report that includes our opinion. Reasonable assurance is a high level of assurance, but is not a guarantee that an audit conducted in accordance with the Standards on Auditing of the Republic of China will always detect a material misstatement when it exists. We describe these matters in our auditors' report unless law or regulation precludes public disclosure about the matter or when, in extremely rare circumstances, we determine that a matter should not be communicated in our report because the adverse consequences of doing so would reasonably be expected to outweigh the public interest benefits of such communication.

Independent Auditors' Report

To the Board of Directors of Eclat Textile Co., Ltd.:

Opinion

We have audited the accompanying consolidated financial statements of Eclat Textile Co., Ltd. and its subsidiaries (the "Group"), which comprise the consolidated balance sheets as of December 31, 2024 and 2023, and the consolidated statements of comprehensive income, changes in equity and cash flows for the years then ended, and notes to the consolidated financial statements, including a summary of significant accounting policies.

In our opinion, the accompanying consolidated financial statements present fairly, in all material respects, the consolidated financial position of the Group as of December 31, 2024 and 2023, and its consolidated financial performance and its consolidated cash flows for the years ended December 31, 2024 and 2023 in accordance with the Regulations Governing the Preparation of Financial Reports by Securities Issuers and with the International Financial Reporting Standards ("IFRSs"), International Accounting Standards ("IASs"), Interpretations developed by the International Financial Reporting Interpretations Committee ("IFRIC") as well as related guidance endorsed and issued into effect by the Financial Supervisory Commission of the Republic of China.

Based on our judgment, the key audit matters that should be disclosed in this audit report are stated as follow:

Revenue recognition and cut off

Please refer to note 4(p) for details of the accounting policies of the recognition of revenue and note 6(q) revenue from contracts with customers.

How the matter was addressed in our audit:

Revenue recognition of the Group is the main concern of the consolidated financial report users. Therefore, the assessment of revenue recognition is the key audit matters in our audit.

Our principal audit procedures included:

Testing the design and implementation of internal control over revenue recognition, inspecting the accuracy of revenue recognition, reconciling between sales systems and general ledger, implementing cut off test of revenues and further inspecting related transaction documents to ensure that the revenue is recorded in the appropriate period.

Other Matter

Eclat Textile Co., Ltd. has prepared its individual financial statements as of and for the years ended December 31, 2024 and 2023, on which we have issued an unqualified opinion.

Responsibilities of Management and Those Charged with Governance for the Consolidated Financial Statements

Management is responsible for the preparation and fair presentation of the consolidated financial statements in accordance with the Regulations Governing the Preparation of Financial Reports by Securities Issuers and IFRSs, IASs, IFRIC, interpretation as well as related regulations endorsed and issued into effect by the Financial Supervisory Commission of the Republic of China, and for such internal control as management determines is necessary to enable the preparation of consolidated financial statements that are free from material misstatement due to fraud or error.

In preparing the consolidated financial statements, management is responsible for assessing the Group's ability to continue as a going concern, disclosing, as applicable, matters related to going concern and using the going concern basis of accounting unless management either intends to liquidate the Group or to cease operations, or has no realistic alternative but to do so.

From the matters communicated with those charged with governance, we determine those matters that were of most significance in the audit of the consolidated financial statements of the current period and are therefore the key audit matters. We describe these matters in our auditors' report unless law or regulation precludes public disclosure about the matter or when, in extremely rare circumstances, we determine that a matter should not be communicated in our report because the adverse consequences of doing so would reasonably be expected to outweigh the public interest benefits of such communication.
